#### 2.3 Correction RM Resolution 2024-299

BE IT RESOLVED THAT R.M. of Grahamdale Council authorize the correction of Resolution No. 2024-299 to show the correct By-Law No. 1077-2023 as follows:

WHEREAS Peter Hofbauer operates Steep Rock Kayak and Canoe, a kayak, canoe, paddle board and motorized boat rental business in Steep Rock.

AND WHEREAS Mr. Hofbauer operates the business using the Municipality's boat launch, marina, dock, parking area and adjacent municipal land.

By-law 1075-2023 prohibits the use of the boat launch, marina, dock, parking area and municipal land for commercial purposes without the operator first applying for and obtaining permission from the Municipality. **By-law 1077-2023** provides rules for the use of the boat launch, marina, dock and parking area.

In violation of By-laws 1075-2023 and **By-law 1077-2023** Mr. Hofbauer operates his Steep Rock Kayak and Canoe business from the boat launch, marina, dock, parking area and municipal land without having obtained permission to do so in violation of By-law 1075-2023 and also continues to violate the operating rules set under **By-law 1077-2023**.

The Municipality has repeatedly requested that Mr. Hofbauer apply for the required permission under By-law 1075-2023 and comply with the operating rules under **By-law 1077-2023** and to stop operating and using the municipal land and facilities until he does so. Despite the repeated requests, Mr. Hofbauer continues to operate his business and has failed to apply for the required permission or to comply with **By-law 1077-2023** operating rules.

BE IT RESOLVED THAT Peter Hofbauer and the operation of Steep Rock Kayak and Canoe are hereby prohibited from using, occupying or attending the municipal boat launch, marina, dock, parking area and the adjacent municipal land effective immediately.
